THIS RESERVATION SERVICES AGREEMENT (the "Agreement") is made and entered into as of this «CONTRACT_STARTDATE», by and between InnLink, LLC, a Tennessee limited liability company ("InnLink"), and «CONTRACT_OWNER_LEGAL_COMPANY_NAME» (the "Company"). This Reservation Services Agreement is governed by the AAHOA Master Association Services Agreement. The AAHOA Master Member Reservation Agreement is available through AAHOA.

InnLink has developed the InnLink Central Reservation System (the "InnLink System") for guest lodging facilities; and the Company is desirous of using the InnLink System for its Property's reservation system using those reservation methods as are set forth below.

Length of Agreement: The initial term of this Agreement shall commence upon the date of this Agreement and shall continue for a period of 12 months following the activation of the first reservation service initiated by InnLink. Thereafter, this Agreement shall automatically renew for a successive 12 months unless either party gives written notice to the other at least thirty (30) days prior to the end of the current term.

Implementation and ongoing fees: Company shall pay to InnLink the monthly fees, transaction fees, and such other fees as set forth below and further described in the AAHOA Master Member Reservation Services Agreement.
